Why has my company been selected to participate?

Our sustainability approach covers the entire life cycle of a product, making it critically important for our suppliers and those who serve them to conduct business in a responsible, ethical and sustainable manner. We have selected our key suppliers that posed the greatest sustainability risk to our company or are positioned in our top spend levels. These suppliers contributed the most to our carbon footprint, possessed preferred status, were sole sources of supply, were located in emerging or high-risk countries or provided regulated commodities.

What happens if I don't want to participate?

Our suppliers are important partners in our sustainability journey and we expect the highest levels of engagement in sustainability. We count on cooperation and commitment to continuously improve, and EcoVadis was our selected solution to bring transparence to this process. Situations where our suppliers are not open to engage with the assessment will be individually evaluated by our leadership and may result in loss of future or current business opportunities.

Why do I have to pay for this service?

To ensure the confidentiality and control of your data, you must subscribe directly with EcoVadis for your assessment. You will also own the results. The annual subscription fee covers: The expert analysis and creation of your sustainability/CSR scorecard with benchmarks, strengths and improvement areas, performed by the EcoVadis sustainability analyst team (one per year); access to the online sustainability/CSR platform where you can manage sharing of your sustainability/CSR scorecard, use the Corrective Action Plan module and all the additional content and tools to support your improvement. Will my information be kept confidential?

Your documents will be kept confidential and will not be shared or distributed without your authorization. Upon completion of the assessment, your rating and scorecard are visible to Alcoa. Any future sharing requests will be processed according to EcoVadis Terms and Conditions. You can decline or revoke sharing to any requestor via the EcoVadis platform. If you are eligible for an EcoVadis Recognition medal (where relevant), it may be displayed on the EcoVadis network according to their Terms and Conditions. Please see the EcoVadis Trust Center to view their certifications and commitments to information security and data privacy.

How will Alcoa use my EcoVadis scores and assessment results?

Your data is confidential and will be used only by the EcoVadis service, and your Scorecard will be available only to the customers you approve. Your performance results will be systematically integrated into our Sourcing Process and in our Supplier Relationship Management (SRM). If you already are an EcoVadis CSR registered user, we ask that you grant Alcoa access to your report.

What technical resources do I need?

No software installation is required: EcoVadis uses a web-based solution delivered on a secure platform, and includes updates and technical support. All you need is an internet connection, and to provide the documentation requested in the questionnaire phase.
